  - The same for all product standards
  - Confirmation that all the details entered are correct
  - Final confirmation of acceptance to terms and conditions

This form is to supply the final details necessary to register **AJAMEX3 Version 5** for the TOGAF™ Certification (DEMO) certification program.

This is done in three stages :

- This form allows you to check all the information relating to your company, the Authorized Signatory, the product and the registration request. It is divided into sections; each one needs confirmation that it is correct. If you need to update any information (such as company details) you can select an *update* link which will cause a separate browser window to appear for the update. Once you have made the update you should close that window and refresh this page.
- The second part is to make payment.
- The third and final part is to affirm that you are prepared and willing to apply for registration under the terms of the Certification Agreement.

# Re-branding an already Certified Product

---

Re-branding an existing TOGAF Training Product or TOGAF Tool Support

The TOGAF Certification Policy includes the concept of *Re-branding* an already certified TOGAF Tool Support or TOGAF Training product. This allows for technically identical products to be delivered by multiple suppliers, and since the product is already certified less supporting evidence is required
